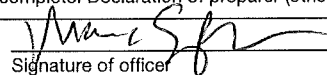

SUMMER PLACEMENT AND MENTORING: Summer Experiential Education Programs - each student receives two full scholarships to life changing summer experiential education programs, including wilderness leadership expeditions, academic enrichment programs, community programs and home-stay abroad. These programs enable students to push themselves and succeed beyond what they think is possible physically, emotionally and intellectually. Weekly mentoring - full time staff work one-on-one providing holistic support and challenging students to gain greater self-awareness and accept responsibility for their growth and academic success. through mentoring, students build a trusting and enduring relationships with an adult, some for the first time in their lives.

Staff training and development: Summer Search conducts a strong training effort to teach the uniquely effective interview process that identifies students that have leadership potential through an original youth development model that identifies three character metrics that it hopes to cultivate in young people: resiliency, altruism, and performance. The Organization provides a comprehensive training program to staff in order to develop and improve mentoring skills which can help students develop relational, leadership and resiliency skills. Training is conducted year-round through a series of intensive workshops delivered in person by highly-trained staff and youth development experts.

College success: Summer Search knows that it is not enough to get students to college, but it is important to support them so they can attain a Bachelor's Degree and are set up for future success. The first few years of college can be extremely challenging, particularly for first generation college students. For this reason, Summer Search supports students through this transition and offers professional development and career readiness services so they graduate with the network, skills, and experiences necessary to competitively enter the workforce. Our College Success staff support students throughout their post-secondary education, especially in their first two years of college (when risk of drop-off is highest), to ensure they are progressing academically, securing financial aid, engaging on campus, and adopting effectively. We provide college students with on-going mentoring, college and financial aid counseling, professional internships, robust networking opportunities with effective role models, career development support, peer support, and philanthropic opportunities.
